

Brewery Membership – Terms & Conditions

1. *Brewery Membership* is operated by: The Kendal Brewery Arts Centre, 122a Highgate, Kendal, Cumbria, LA9 4HE (owned and operated by the Kendal Brewery Arts Centre Trust Limited – registered charity 01086789) referred to hereafter as Brewery Arts and our catering Kendal Catering Company referred to hereafter as KCC.
2. *Brewery Membership* is a donor-scheme with financial and non-financial benefits, which are determined by and at the discretion of Brewery Arts in return for a fixed annual fee. Being part of *Brewery Membership* does not extend to any aspect of the management or governance of Brewery Arts, the Kendal Brewery Arts Centre Trust Limited (KBACTL) and its subsidiary KCC.
3. *Brewery Membership* is valid for one year from the date of purchase.
4. *Brewery Membership* discounts cannot be applied retrospectively to tickets already purchased.
5. *Brewery Membership* is valid only for the named holder and is non-transferable and non-exchangeable.
6. *Brewery Membership* benefits cannot be used in conjunction with any other offer or promotion. All offers are subject to availability.
7. The free two cinema tickets are for the member use only and are provided each year on renewal of membership. They cannot be redeemed against live screenings and designated special film presentations.
8. *Brewery Membership* cannot be used to obtain a discount when buying a Family Ticket for a film screening or live event.
9. Individual members are entitled to one reduced rate per ticketed arts event or film screening
10. Normal ticketing conditions, including a booking fee, apply.
11. 10% Cinema discount on *Brewery Membership* applies only to full price Adult Tickets (currently £8.50) and Silver Screenings (currently £7.50). The following are excluded from Cinema tickets and discounts: Silver Film Parties, Cinema Bambino, Students, Under 16's & 17-24 are already discounted –.Also, any events that are one-offs. Any special event screenings with an alternative price band are excluded from the Membership offer.
12. £6 cinema tickets are available for all members on Sundays.
13. To become a member, you must be 18 or over. If you are under 18, please ask a parent or guardian to register and remain liable on your behalf.
14. By signing up for *Brewery Membership* you give your consents to receiving membership communications from the Kendal Brewery Arts Centre Trust Limited relating to your membership. Members` details will not be passed on to any third parties without your permission outside those required to operate the scheme.
15. *Brewery Membership* is entitled to 10% off the total food bill when ordering in the restaurant and bar. All drinks and beverages are excluded from this offer. Only one membership discount can apply per meal bill on a table of a maximum of 6 people.
16. Food purchases at the Cinema Kiosk are not included. All drinks and beverage are excluded. The offer doesn't apply to seasonal and special promotions offered throughout the year.
17. 30% on room hire subject to availability and must be booked in advance.
18. Standard Terms of Admission apply.
